**S.C.C. Application No. PL/17/15 Lawshall C.V. school:** hardplay extension. The Councillors discussed this application and are withholding their approval of the plans until confirmation is received that the parking area and footway will take place. The Clerk will contact S.C.C. to advise them of the Councillors decision.

**Application No. B/15/00702/FHA: Magnolia Cottage: Bury Road:** erection of single storey side extension. The plans were discussed and there were no objections.

**Application No. B/15/00784/FHA: Potash Farm, Donkey Lane:** erection of outbuilding with platform (treehouse) (Retention of). The plans were discussed and there were no objections.

#### Planning Permission granted for the following:

**Application No. B/15/00313/FHA/JC: Langdon, The Green:** erection of 1½ storey rear extension (demolition of existing conservatory).

**Application No. B/15/00484/FUL/JD: land south of Mages Yard, Lambs Lane:** erection of 1 detached dwelling (amended to that approved under B/12/01095/FUL) with siting of building moved 1.8m to the south and relocation of bin/log store to fulfil the required clearance of an underground electric cable.

### 29 CORRESPONDENCE:

**Email received from Shimpling Parish Council:** re: bus service for Shimpling children. This will no longer be available for those children who live less than 3 miles away from Lawshall school. This email also points out that the current parking problem at the school will increase as more parents will bring their children to school as it is too far and not safe for youngsters to walk. Cllr. R. Kemp is dealing with this on behalf of Shimpling and Mr Kemp asked the Lawshall Clerk to contact Shimpling P.C. stating to say that they had the full support of Lawshall P.C. (**Note:** The Clerk has contacted Shimpling P.C. Clerk re: the above)

**Path from Shepherds Drive to Walcher's Meadow:** this needs some attention.

**Playground:** To state that dogs **are not** allowed within the playground area. The Clerk will provide a new notice with the ages for use of the equipment.

**Ditch along Lambs Lane:** To ask residents **not** to dump their garden rubbish in this ditch and to point out that these ditches have been recently cleaned out to prevent flooding.

**Be Aware:** To make sure all dwellings, outbuildings, sheds and garages and entrance gates are made secure to deter criminals breaking into their property and stealing various items.
