Village Hall: Mr John Payne: Reported that the village hall is now open after the devastating storm which flooded the village hall on 19<sup>th</sup> September 2014. The floor has been replaced and the hall decorated. . Floor replacement was £10,000.00. Total cost of repairs is £23,600.00. The committee are still waiting for some more funding. At present they have lost some regular bookings.

F.O.C: Mr Ian Carrington: Reported that they have a good contact with the school and the children take part in various activities. On 15<sup>th</sup> August 2015 there will be a barbeque and a scarecrow festival. Residents can be part of the New Friends of Woodland at £2 per month. A visit by PNG is expected in June 2015.
